APPLICATION FOR LEAD SERVICE LINE REPLACEMENT GRANT AND LOAN PROGRAM

You may be eligible to receive financial assistance to fund the replacement of lead service line (LSL) in the City of Sheboygan. Grants may be available from funds the City of Sheboygan obtained through the State of Wisconsin's Safe Drinking Water Loan Program. Available grants will range from 0% to 100% based on census tract data determined by the WDNR. Property owners may receive a 0% interest loan to cover remaining costs. Grants are subject to availability of WDNR funding. If grants are temporarily unavailable, the Utility will provide updates on a timely basis. Completed applications should be returned to the Utility office or

LeadProgram@sheboyganwater.org.

If you will be contracting directly with a plumber for the LSL replacement from the SWU preferred plumbers list, not as part of a road construction project, please include a copy of at least two quotes/bids. Work must be completed within 60 days of the application approval date, and the final invoice must be submitted to Sheboygan Water Utility within 30 days of the work completion date.
